Crime(s) of which convicted and classification(s): Violation of Penal Code section 182, subdivision (a)(1), (conspiracy to commit the crime of referring of clients for compensation, a violation of Labor Code section 3215), a felony, and a crime that may involve moral turpitude or other misconduct warranting discipline. (See *In re Strick* (1987) 43 Cal.3d 644, 653 [where crime standing alone may not implicate fitness to practice law, inquiry may be made into circumstances surrounding the crime].)

Violations of Penal Code section 549, (soliciting, accepting, or referring business to or from anyone with knowledge or reckless disregard, whether the person for or from whom the referral is made, intends to violate Penal Code section 550 or Insurance Code section 1871.4), three counts, felonies and crimes which may involve moral turpitude or other misconduct warranting discipline. (*In the Matter of Oheb* (Review Dept. 2006) 4 Cal. State Bar Ct. Rptr. 920 [a violation of Penal Code 549 does not inherently involve moral turpitude but did result in disbarment based on the facts and circumstances of the conviction].)

Violations of Penal Code section 550, subdivision (b)(3), (to, or knowingly assist another in, concealing or failing to disclose an event that affects a person's right to insurance benefit), 33 counts, felonies involving moral turpitude per se. (See *In re Lesansky* (2001) 25 Cal.4th 11, 16 ["Criminal conduct not committed in the practice of law or against a client reveals moral turpitude if it shows a deficiency in any character trait necessary for the practice of law (such as trustworthiness, honesty, fairness, candor, and fidelity to fiduciary duties)..."]; see also *People ex rel. Government Employees Insurance Company v. Cruz* (2016) 244 Cal.App.4th 1184 [elements generally necessary to find violation of section 550 are knowing presentation of a false claim with intent to defraud].)

3. Compliance with Rule 9.20. (Applicable only if checked.)

We bring to the Court's attention that, should the Court enter an order of interim suspension herein, the Court may wish to require the above-named attorney to comply with the provisions of rule 9.20, California Rules of Court, paragraph (a), within 30 days of the effective date of any such order; and to file the affidavit with the Clerk of the State Bar Court provided for in paragraph (c) of rule 9.20 within 40 days of the effective date of said order, showing the attorney's compliance with the provisions of rule 9.20.

[ X ] 4. Other information to assist the State Bar Court

OCTC filed the initial “Transmittal Records of Conviction of Attorney – without Finality” (Transmittal) on September 15, 2022. The Transmittal specified that the verdict forms attached to the Transmittal for respondent’s conviction were incomplete and lacked count 29. OCTC further stated that it would file a first supplemental transmittal when it received proof of the conviction to count 29. Attached please find a copy of the Minutes for respondent’s criminal case. The Minutes, along with the Fourth Amended Information, (filed with the Transmittal) reflect respondent’s conviction for: a violation of Penal Code section 182, subdivision (a)(1); three violations of Penal Code section 549; and 33 violations of Penal Code section 550, subdivision (b)(3) (including count 29).

The Minutes provided to OCTC by the trial court, (received by OCTC on September 16, 2022) contained 413 pages and was in seven parts. OCTC provides the last part, “7 of 7”, in this supplemental transmittal. Parts 1 through 6 can be provided by OCTC upon request.

The certified copy of the Minutes for respondent’s case states the document contains 52 pages. The certification stamp is on the back of the last page making the total number of pages provided to this Court to a total of 53 pages.
